### Pumpkin Patrol

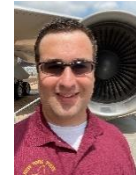

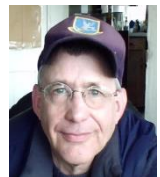
### Assistants Named

**Wells Farr (WB3CUF)** has been named as the ARES Assistant Emergency Coordinator



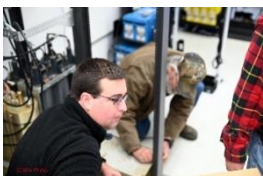
### Equipment Inventory
